On September 1st, 2021 AGP experienced a disruption in our supply chain when a malfunction occurred with our ship loader at the Port of Grays Harbor in Aberdeen, WA. AGP's Ag Products and Processing divisions, along with our Transportation team, immediately jumped into action to mitigate logistical issues and continue to serve our customers. AGP's Marketing arm was able to find elevation at other ports to continue loading vessels. AGP's Traffic division moved numerous unit trains in route to Grays Harbor to new destinations, all while keeping a steady supply of empty cars returning to our soy processing plants, keeping us fully operational. Concurrently, AGP's Operations and Engineering teams took action by designing and installing a temporary loading

system utilizing mobile telestackers so AGP could continue shipping to our customers from the Grays Harbor terminal. We cannot always control what happens, but we can control how we respond. The pride and dedication of our team is unparalleled. Alongside the efforts of AGP's team, I would be remiss not to mention how fortunate we are to have such a great partner on the ground in Washington. The Port of Grays Harbor staff stood hand in hand with us through some trying times during our business interruption, temporary loading, and rebuild. Thanks to everyone for all their hard work.

On the cover of this issue of AGP News is a picture of the new loader at Terminal 2 which became operational on May 23rd. The startup has gone smoothly and I want to congratulate AGP's Operations and Engineering teams for the success they have accomplished on the rebuild. AGP's Terminal 2 will handle over 20% of U.S. soymeal exports in a given year. In addition, with the planned expansion in the soybean processing industry over the next three years, the need to export meal has never been greater. We are pleased that Terminal 2 is back up and running at 100% and look forward to AGP's new export terminal coming online in 2025.

### Port Grant Discussed with D.C. Leaders




This spring, AGP's Matt Caswell, Vice President of Member and Government Relations. and Paul Wahlmeier, Vice President of Finance, traveled to Washington, D.C. to advocate for a federal grant supporting new investment at the Port of Grays Harbor (POGH) under the Port Infrastructure **Development Program** (PIDP). Representatives of the Port took part in the Commissioner Tom Quigg, **Deputy Executive Director** Leonard Barnes, and **Director of Government** and Public Affairs

During the visit to Washington, D.C., the combined AGP and Port team met with numerous Administration and Congressional policymakers to advocate for the PIDP grant. The team had the opportunity to discuss AGP's and the Port's role in the nation's export of soybean meal to markets overseas, with the PIDP program leaders and members of Congress (including key policymakers from the Midwest and Pacific Northwest). The Port's PIDP grant request has received numerous letters and statements of support from trade associations and state and federal government representatives.





## **Nebraska Officials Tour Hastings Facility**

AGP celebrated this year's National Ag Week with a visit from two special guests. In late spring, Nebraska Governor Pete Ricketts and Nebraska Department of Agriculture Director Steve Wellman met with AGP management at the Company's Hastings, NE processing facility. The meeting featured a presentation from AGP CEO Chris Schaffer explaining current business operations and capital investments being made within the Company. Those projects include a new soybean crush facility in David City, NE and the expansion of AGP's export terminal at Grays Harbor. Both projects are slated to be completed by 2025.

"We want to thank Governor Ricketts and Director Wellman for their visit here today," said Jodie Johnson, Hastings Merchandising Manager. "They asked some great questions and were excited to learn about AGP and how the Company works to promote soybean production and the soybean industry."

The visit ended with a guided tour of the facility, where Ricketts and Wellman learned of the role Hastings plays in AGP's overall business platform.



"What happens in Hastings is about more than crushing soybeans and refining oil. It is also about hiring Nebraskans, giving back to the local community, and making sure our state's farmers can get top dollar for their crop. The way AGP is able to connect those dots is truly remarkable," Ricketts said.

The Hastings facility processes over 60 million bushels of soybeans and refines over 700 million pounds of soybean oil each year. Approximately 80% of the soybean meal produced at the Hastings plant is exported, primarily to Southeast Asia.

## **AGP Applauds Iowa Biodiesel Bill**

AGP representatives attended the lowa biofuels bill signing in May. Iowa Governor Kim Reynolds is a strong supporter of the renewable fuels industry. The Biofuels Access Bill (HF 2128) encourages the sale of higher blends of biodiesel through an incentive-based approach and increases the fuel retailer tax credit.

"lowa's biofuel production powers our economy and fuels the world, and this historic bill sets the stage for the single largest expansion of biofuels in our state's history. We're sending a message that can't be ignored. America's energy is growing right here in Iowa's fields," Reynolds said prior to signing the bill at a family farm in Prairie City, IA.

The bill has garnered a great deal of praise from the agricultural industry and renewable fuels sectors. According to

the Iowa Soybean Association, biodiesel production supports 13% of the price of soybeans, equating to approximately \$1.78 per bushel in 2021. Increased production of renewable fuels also results in reduced feed costs for livestock producers.

### Agribusiness Assoc. of Iowa CEO Visits AGP





In June, Bill Northey, CEO of the Agribusiness Association of Iowa (AAI), visited AGP's headquarters to meet with AGP leaders and discuss his group's policy and education priorities for agriculture in Iowa. Prior to his role as AAI CEO, Northey served three terms as Iowa's Secretary of Agriculture and was appointed as USDA's Under Secretary for Farm Production and Conservation. AAI's membership consists of several hundred Iowa agricultural-related businesses. These include farm supply cooperatives, private grain companies, crop protection companies, equipment dealers, agricultural lending, rural health

organizations, and many other businesses dedicated to serving lowa's agricultural industry. AGP and AAI have a long history of working together on key issues facing lowa agriculture.

"AGP is very excited to welcome Bill into his new role as CEO of AAI. His experience and deep understanding of the role of government in agriculture will serve our industry well, especially as agriculture begins to engage more directly on climate issues," stated AGP Vice President of Member and Government Relations Matt Caswell.
