Over the past several years, AGP has undertaken many capital projects that are a lot like those coveralls. The projects may not be flashy or large, but they continue to provide benefits to our members. The operations and engineering teams at AGP are always focused on improving the safety and efficiency of existing facilities. We intend to continue to re-invest in upgrading all of our plants in order to return value and improve service to our customers and member-owners.

As we look forward, AGP will: replace a portion of the solvent recovery and soymeal finishing equipment at the Hastings, NE South plant; perform a major rail upgrade and drainage project at St. Joseph, MO; upgrade the solvent recovery equipment at the Sheldon, IA facility; install additional automation at the Manning, IA plant; and improve the reliability and predictability of all soy crushing facilities utilizing artificial intelligence (AI). Our existing facilities have, and will continue to be, well-maintained and competitive.

A major portion of this newsletter provides insight into the upcoming Annual Meeting. I hope to see many of you there.

# AGP Hosts Groups at Iowa and Missouri Facilities



Highlighting the importance of education and outreach, AGP recently hosted three groups at various facilities in Iowa and Missouri. In Algona, IA, the Company welcomed Iowa Sen. Joni Ernst and Algona Mayor Rick Murphy (pictured above with AGP employees), offering insights into the challenges and opportunities facing soybean producers in the region. At the Sergeant Bluff, IA facility, representatives from USDA's National Agricultural Statistics Service (NASS) and the National Association of State Departments of Agriculture (NASDA) (pictured bottom-left) explored data-driven strategies for enhancing agricultural reporting and decision-making. Meanwhile, in St. Joseph, MO, the Iowa State University Agribusiness Club (pictured bottom-right) gained firsthand knowledge of industry practices and innovations that bridge the gap between academics and real-world applications.

"These visits provide an opportunity for dialogue on critical topics agriculture is facing," said Michael Dolch, AGP Director of Government Affairs. "Engaging with leaders, policymakers, and the next generation of agricultural professionals is essential for driving the soybean industry forward."





## AGP Breaks Ground on Port of Grays Harbor Project

In late November, the Port of Grays Harbor (POGH) and AGP welcomed more than 125 elected officials, project partners, and community and business leaders for the official groundbreaking of the Terminal 4 Expansion and Redevelopment Project. The Port's Terminal 4 Project will add more than 40,000 feet of additional rail within its Marine Terminal Complex, a new fendering system, and a stormwater collection and treatment facility at T4. Additionally, it will create more than 30 acres of additional cargo laydown area to support future operations at Terminal 4A. AGP's \$170 million project broke ground a month ago and will construct a new commodity export facility at Terminal 4B resulting in increased ag exports, generating additional vessel calls and providing more than 80 full-time, family-wage jobs.



"As a public port district, we strive to utilize our public assets to attract private investment in our community to create jobs and opportunities," said Port of Grays Harbor Commission President Phil Papac. "The Port couldn't have asked for a better partner than AGP as we embark on this transformational project. This will be the largest infrastructure project the Port has ever undertaken, and it will pay dividends well beyond Grays Harbor."

AGP is spearheading this upgrade, which includes a new ship loader at the Port's Terminal 4 facility and already completed, additional storage at Terminal 2. The upgrades and new ship loader will improve logistics for AGP's crush facilities, enhance



production, reduce vessel idle time, and ensure the POGH remains a cost-effective port for soybean meal exports. These investments, scheduled to be operational in early 2026, will ultimately allow the AGP terminal to increase annual soybean meal exports from three million to more than six million metric tons.

"We are ready to load more vessels and grow here in Grays Harbor and this project will make that possible," said AGP CEO Chris Schaffer. "Critical partnerships with our rail partners, ILWU (International Longshore and Warehouse Union) Local 24, and the Port made Grays Harbor an easy choice 20 years ago and we couldn't be more certain of it today. This groundbreaking is a pivotal step for AGP and the Port, and we look forward to more success here in Grays Harbor."

"We are so very grateful for all of those who were able to join us to celebrate today, especially the Quinault Indian Nation and our project funding partners of the federal delegation, MARAD, the State of Washington, Grays Harbor County, and the Soy Transportation Coalition," Papac said. "Your support and recognition of this project's many benefits are invaluable, and we appreciate the partnership."

The groundbreaking comes several months after the project received a \$1.3 million contribution from representatives of the soybean industry to help offset some of the pre-engineering, design, and site development costs of the Port of Grays Harbor Terminal 4 Expansion and Redevelopment Project.

#### Randy Houser **FEATURED ENTERTAINMENT**



Randy Houser first made an impression as a Nashville songwriter in the mid-2000s, scoring a big hit when Trace Adkins recorded his "Honky Tonk Badonkadonk" in 2005, a success the Mississippi native parlayed into a recording contract in 2008. Over the next five years, he slowly climbed his way into the Country Top Ten, earning

Country Airplay number ones.

Signing with the indie Stoney Creek Records, Houser released How Country Feels in 2013. Its title track, which was released ahead of the album, reached number one on Billboard's Country Airplay, as did its successor "Runnin' Outta Moonlight." Its other two singles -- "Goodnight Kiss" and "Like a Cowboy" -- reached two and three, respectively.

He followed that with 2019's Magnolia, a shift in musical style that mirrored throwback traditionalists like Chris Stapleton. Through it all, Houser maintained his own identity, holding tight to his heart and humor.

Over the next couple of years, he pursued work in films, appearing in the inspirational baseball film The Hill in 2022, and Martin Scorsese's 2023 award-winning Killers of the Flower Moon. Houser returned with his sixth album, the relatively reflective *Note to Self*, in November 2022.

# AGP Calls for Changes to LCFS

This fall, Allison Willis, AGP's Director of Sustainability, testified at the California Air Resources Board (CARB) public hearing in Riverside, CA on proposed amendments to the Low Carbon Fuel Standard (LCFS). In her testimony, Willis acknowledged the LCFS's essential role in reducing greenhouse gas (GHG) emissions, but expressed concerns about certain proposed changes. She urged CARB to reconsider the 20% cap on vegetable oil feedstocks, warning it could lead to the displacement of

vegetable oil feedstocks, warning it could lead to the displacement of
U.S.-grown soybean oil with imports linked to deforestation. Willis also recommended delaying the implementation of new sustainability requirements to provide farmers with adequate time to adjust, and emphasized the importance of updating outdated land-use change models with current scientific data. Additionally, she highlighted potential challenges in replacing existing row crop feedstocks, cautioning that such a rapid transition could reduce renewable fuel availability, increase

# Spackler Inducted into Iowa Cooperative Hall of Fame

This recognition celebrates Spackler's remarkable contributions to agribusiness and the cooperative industry over a career spanning more than 40 years. Many

years as CEO, during which the company experienced significant growth and profitability. His leadership left

a lasting mark on the organization and the broader cooperative community. In 2021, Spackler retired from his role at AGP, and was named National Cooperative Manager of the Year by the National Council of Farmer Cooperatives the following year.

"Being inducted into the Iowa Cooperative Hall of Fame is a tremendous privilege. This recognition is a testament to the incredible teams I have had the opportunity to work with and the unwavering dedication of our member-cooperatives and farmer-owners. I'm proud to have been part of such a meaningful industry that supports agriculture and rural communities," Spackler said.

## 2025: International Year of Cooperatives



The United Nations General Assembly has declared 2025 as the International Year of Cooperatives (IYC2025) to be celebrated under the theme "Cooperatives Build a Better World." The theme highlights the lasting global impact of cooperatives and emphasizes that the cooperative model is a crucial solution for addressing various global challenges. Additionally, it underscores the significant role cooperatives play in advancing the implementation of the Sustainable Development Goals by 2030. The official launch of the IYC2025 took place in New Delhi, India, during the International Cooperative Alliance's Global Cooperative Conference and General Assembly in November. The UN first declared 2012 as the International Year of Cooperatives with the theme "Cooperative Enterprises Build a Better World".



With football season in full swing, AGP held its annual Iowa State tailgate event in November at Jack Trice Stadium in Ames, IA. Thirty member-cooperatives from the surrounding area were invited and AGP employees (pictured above) helped make the day a resounding success, bringing everyone together to celebrate community, connection, and Cyclone football.


